

GET YOUR TAXES DONE FOR FREE



If your household income was less than \$60,000 in 2016, you may be eligible to file your taxes for free and keep more of what you earned with valuable tax credits.

It's simple and FREE!

- File your own taxes at MyFreeTaxes.com.
- Or, schedule an appointment at a free tax preparation site by calling one of the approved locations on the back of this flyer.

If you worked during 2016, and your household earned income was less than \$53,505, you may be eligible to receive the Federal and California Earned Income Tax Credits (EITC) of up to \$6,000.

WHAT DO I BRING WITH ME?

- Picture Identification
- Social Security Card or Individual Taxpayer Identification Number (ITIN) Letter for all individuals listed on the return
- W-2s, 1099s, and all other tax-related documents for 2016
- Form 1095-A, B, or C, Health Insurance Coverage Stmt.
- All 1098 E&T forms for educational expenses
- Childcare provider name, address, phone number & Tax ID Number
- Voided check if using direct deposit for refund
- Copy of your 2015 income tax return
- For joint returns, both spouses must be present to sign the required forms

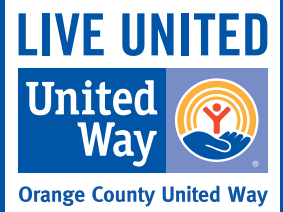
HOW DO I QUALIFY FOR EITC?

- Be a U.S. citizen or resident alien for all of 2016
- Have a social security number valid for employment
- Earned income during 2016
- Cannot use "Married Filing Separately" filing status
- Cannot be claimed as a qualifying child
- Cannot file Form 2555 or 2555-EZ (relating to foreign earned income)
