If your household income was less than \$60,000 in 2018, **you may be eligible to file your taxes for free!**

IT'S SIMPLE!

- File your own taxes at MyFreeTaxes.com.
- Or, **schedule an appointment** at a free tax preparation site. Call one of the locations on the **back of this flyer**.

If you worked in 2018 and your household earned income was less than \$55,000, you may qualify for cash-back tax credits that can increase your refund! **You must file your taxes to claim the credits!**

WHAT DO I BRING WITH ME?

- Picture Identification
- Social Security Card or Individual Taxpayer Identification Number (ITIN) Letter for all individuals listed on the return
- W-2s, 1099s and all other tax-related documents for 2018
- Form 1095-A, B or C health insurance coverage statement
- All 1098-E and T forms for educational expenses
- Childcare provider name, address, phone number and Tax ID Number
- Account number for direct deposit refund
- Copy of your 2017 income tax return
- For joint returns, both spouses must be present to sign the required forms

DO I QUALIFY FOR CASH BACK?

The expanded California Earned Income Tax Credit (CalEITC), along with a similar federal credit, can result in hundreds, or even thousands, of extra dollars in your pocket!

The amount of CalEITC you may be eligible for depends on how much money you earn from work. You may be eligible if you:

- Are 18 years or older
- Work for an employer or are self-employed
- Have a Social Security Number valid for work
- Lived in California for at least half the tax year

In addition to CalEITC, you may also be eligible for the federal EITC if you earn less than \$55,000.
